#### Education for a Connected World - 2020 edition





Released just before the summer break this is a timely update to the first edition published in Spring 2017.

This free document from the **UK Council for Internet Safety** is a framework to equip children and young people for digital life.

It covers four age ranges, 4-7, 7-11, 11-14 and 14-18 and looks at eight different aspects of online safety.

The framework aims to support the development of the curriculum and is of particular relevance to PSHE education, Relationships and Sex Education, Health Education and Computing.

It is designed, however, to be usable across the curriculum and to be central to a whole school approach to safeguarding and online safety.


To help support parents, carers, and young people with additional learning needs, internetmatters.org have created this hub to offer tailored advice on how to connect safely online across a range of social platforms.

## Papyrus Bedtime Stories Chapter Two – for staff and parental use only



Stars including actors Michael Sheen, Julie Hesmondhalgh and Carrie Hope Fletcher have taken part in the celebrity Bedtime Stories campaign launched by anti-suicide charity **Papyrus**.

The Warrington based organisation wants to help protect children from the nightmare of cyber bullying and harmful online content and has created a series of videos featuring high-profile faces. The actors are joined by Anton Danyluk, former Love Island star, to complete the line-up.

The hard-hitting films narrated by the celebrities are designed to raise awareness of the impact online bullying and dangerous content can have on children and young people.

In the short films, Michael Sheen reads 'Annabelle and The Trolls', Julie Hesmondhalgh reads about 'Rachel and the Rabbit Hole', Anton Danyluk reads 'Benji and the Keyboard Warrior', while Carrie Hope Fletcher reads 'Harry and The Haters'.

Michael Sheen said: "I'm incredibly proud to be part of the campaign, which highlights the very real dangers that young people face in our increasingly digital world.

"Bedtime Stories speaks to those with young children, or indeed young people in their lives, raising awareness of how the online environment can impact on the mental health of those using it and reminds them that Papyrus is here for them, should they need help and support."

#### A Guide to Facebook's Family of Apps for Schools

This 12- page guide for schools and teachers, provides guidance on how to help staff use Facebook's family of apps in a safe, professional, and positive way.

In some schools, staff might choose to use Facebook's WhatsApp service to help them stay in touch with each other, or the school might use their official Facebook Page to communicate to the wider community of parents and carers.

The apps which are extensively covered include:

- WhatsApp
- Facebook Pages
- Facebook Groups
- Facebook Live
- Facebook Messenger

The guide focuses on two use cases:



- Broadcasting school messages to a wider audience through an official school channel such as a Facebook Page.
- To communicate for internal purposes between smaller groups of people through school-sanctioned or unofficial channels such as WhatsApp and Facebook Groups.
