## Pupil Premium Policy

### Rationale

*At St Anne Stanley CE Primary School we take seriously our responsibility to use the Pupil Premium Grant to improve the outcomes for children identified as socially disadvantaged. At St Anne Stanley CE Primary School we are committed to meeting their academic, pastoral, social and academic needs in a nurturing and caring environment. The Pupil Premium will be used strategically for every entitled child to develop their true potential, irrespective of need.*

### Aims

- *At St Anne Stanley we will aim to be fair and transparent in our use and distribution of the Pupil Premium funding.*
- *At St Anne Stanley we will ensure that teaching and learning opportunities meet the needs of all of the pupils and in particular those identified as being socially disadvantaged.*
- *At St Anne Stanley we will ensure that appropriate provision is made for pupils who are identified as belonging to vulnerable groups, this includes ensuring that the needs of socially disadvantaged pupils are adequately assessed and addressed*
- *At St Anne Stanley in making provision for socially disadvantaged pupils, we recognise that not all pupils who receive free school meals will be socially disadvantaged.*

### Priorities for Use of Pupil Premium

At St Anne Stanley CE Primary School our priorities for using the Pupil Premium are as follows;

- **Pupil Performance** - *To narrow the gap for those pupils not on track to achieve year group expected standards through the use of targeted and strategic support.*
- **Enrichment** - *Provide experiences in order for pupils eligible for FSM for example additional after school clubs and offsite visits.*

- **Social and Emotional Support** – Provide additional adult support to help facilitate attendance, punctuality and social and emotional development for identified children.

### Provision at St Anne Stanley CE Primary School

At St Anne Stanley the provision we may provide using the Pupil Premium funding includes:

- Providing additional small groups which are strategic and targeted to identified pupils and aim to reduce gaps in basic Literacy and Mathematics skills.
- Providing additional teaching and learning opportunities through the use of expert teachers and any group that could enhance the provision and outcomes for children entitled to the PPG.
- Providing teaching and learning aimed specifically at accelerating progress made by identified children to at least that expected for their age.
- If eligible children have been identified as able, gifted or talented extra support and teaching will be provided to ensure those children meet their full potential.

At St Anne Stanley we understand that not all pupils who are socially disadvantaged are registered or qualify for free school meals and therefore could be disadvantaged by stringent criteria for the distribution of the Pupil Premium Grant. At St Anne Stanley we reserve the right to allocate the Pupil Premium funding to support any pupil or groups of children the school has identified as being socially disadvantaged.

At St Anne Stanley CE Primary School Pupil Premium funding will be allocated following a thorough needs analysis which will identify priority children.

### Reporting Effectiveness of Pupil Premium Grant

At St Anne Stanley the Headteacher will produce a report each term to the Governing Body on the use and effectiveness of the PPG.

The report will include the following information;

- ✓ A detailed analysis of the progress made by children and identified groups in terms of narrowing the achievement gap.
- ✓ Provision for identified children and groups across the school.
- ✓ An analysis and evaluation of the effectiveness of the allocated PPG.

At St Anne Stanley CE Primary School the Governors will ensure that there is an annual statement on how the Pupil Premium funding has been used which will be made available to parents and published on the schools website.
